The chair of the planning committee should be consulted before such meetings take place, or in his absence the vice-chair. Following any such meeting a short briefing note shall be circulated to all planning committee members as soon as is reasonably practical, but no later than before the next planning committee. This is to ensure all planning committee members are informed, without exception, on all formal and informal discussions occurring about planning applications."
